WAIVER RELEASE AND INDEMNIFICATION FOR SHOOTERS AGED 12 - 15 YEARS

The undersigned acknowledges that use of, participation in and/or attendance at the Glen Cove Range, Lattingtown Road, Glen Cove, involves certain risks, and the undersigned assumes and accepts full responsibility for these risks. In consideration of being permitted to use the Glen Cove Range facilities, the undersigned agrees that neither the Glen Cove Range Commission, the City of Glen Cove nor any of its agents or employees shall be liable on account of any claim arising out of personal injury, illness or death suffered by the undersigned while at the Glen Cove Range.

For the consideration aforesaid, the undersigned waives, releases and discharges any and all claims, whether anticipated or unanticipated, including without limitation, claims based on acts of the Glen Cove Range Commission, the City of Glen Cove or any of its agents or employees, which the undersigned, or the heirs, executives, administrators, or assigns of the undersigned, might have against any such person on account of any personal injury, illness or death suffered by the undersigned and the undersigned will exonerate, indemnify and hold harmless the Glen Cove Range Commission, the City of Glen Cove and all of its respective agents and employees, from and against any and all claims asserted by the undersigned or any such third person of the undersigned on account of any such personal injury, illness or death suffered by the undersigned.

USE OF RELOADED AMMUNITION - Due to various insurance concerns, the undersigned further acknowledges that the use of personal reloaded ammunition (*not including factory reloads*) has inherent risks and dangers and shall only be utilized at the range by the individual who actually reloaded such ammunition. It is further expressly agreed that the aforesaid language of the waiver, release and indemnification set forth above shall extend to and include any personal injury, illness or death suffered by the undersigned or any other range participant due to the use of personal reloaded ammunition.

As the parent or legal guardian of a minor child, I hereby accept all responsibility and risk (as outlined in the paragraphs above) associated with the use and/or attendance at the Glen Cove Range, Lattingtown Road, Glen Cove for my child:
